Waiver and Release Agreement

I acknowledge that I am aware of all the dangers inherent in skin diving and SCUBA diving, and am competent to follow the basic safety rules for above and underwater activities.

I understand and agree that the diving and other activities coordinated by the Redwood Empire Divers Scuba Club (Club) are strictly for recreational purposes. I further understand and agree that Club leaders, members, or other participants are not guardians of my safety while I am engaged in Club activities.

I expressly acknowledge that the decision to engage in diving on any given day and/or location is my responsibility and that I am solely responsible for determining my level of competence with regard to any Club activities. I understand and agree that it is neither the responsibility nor the practice of the Club to ascertain the competence level of persons participating in Club activities, but it is the practice of the Club to discourage participation in activities that are beyond an individual's level of competence.

I understand that Club leaders, members, and/or other participants in Club activities may provide advice and/or assistance to me during Club activities. I expressly acknowledge that such advice and/or assistance, if provided, are NOT an acceptance of responsibility for my safety while I am participating in Club activities. I expressly agree to hold the Club and Club leaders harmless for such actions, whether ultimately determined to be negligent or otherwise on the part of the leaders, members, and/or other participants. I expressly acknowledge that I neither expect nor require the Club leaders, members, or other participants in Club activities to supervise or control my diving activities in any way.

By signing this Waiver and Release Agreement, I expressly assume all responsibility for my safety and agree to hold the Club harmless for any personal injury, property damage or death suffered while I am participating in a Club activity, even if such injury, damage or death is found to be caused by the negligence of the Club leaders, its members, or other participants in Club activities.

If any portion of this Waiver and Release Agreement is found not to be effective under California law that portion shall be stricken and the remainder of the terms in this Waiver and Release Agreement shall continue in full force and effect.

I acknowledge that I have read and that I understand the terms of this Waiver and Release Agreement and agree to be bound by the terms and conditions stated herein.
